## PM: 'Outdated' Cong can't question 'Modi guarantees'

| rime Minister (PM) Narendra Modi on Wednesday accused the Congress, whose Karnataka Chief Minister (CM) Siddaramaiah and ministers protested the Centre's "injustice" in the devolution of funds to the state, of shaping narratives that could threaten the unity of the country, such as the North versus South debate that the party had triggered. <br> In his 90-minute speech in the Rajya Sabha, his reply to the debate on the Motion of Thanks to the President's address, the PM detailed his government's vision for the next five years since a "Modi 3.0" was now "imminent". He said it was "Modi's guarantees" that all the welfare schemes, such as Ujjwala, health insurance, free food to 800 million people, and those for farmers, will continue. <br> In his third term, Modi said his government will strive to provide a "Modi kavach", or shield, to empower the people of India, especially the neo-middle class, the 250 million people lifted out of poverty in the past decade. <br> Of late, the PM had spoken of his government working for "four castes" or "four pillars", namely the poor, the youth, women, and farmers. But in Wednesday's speech, Modi specified that the "labharthi", or beneficiaries, of these schemes, were primarily the Scheduled Castes (SCs), Scheduled Tribes (STs), and Other |
